## Florida International Trade Summary 2019



As concerns about the global economy, trade tariffs, elections in Latin America, and potential impacts of Brexit came to fruition - Florida's *total merchandise trade* in 2019 remained nearly flat - ending the year with an increase of just 0.1% (*\$153.6 billion*).
*Merchandise exports* (goods shipped from or through the state) declined by -1.6%, ending at *\$72.3 billion* while *imports* increased by an equal 1.6% to *\$81.3 billion*.
*Florida-origin exports* fell by 2.1% to *\$56.0* billion, but moved up to become the 7th largest export state in the U.S., from 8th place in the past two years.


